Mouw/Stecker moved/seconded to approve the District Career and Academic Plan. This plan is a component of district reporting that provides a framework for each student's individual career and academic plan. All aye vote. Motion carried.

Gruys/Hamm moved/seconded to approve the 2024-2025 school calendar. All aye vote. Motion carried.

Mouw/Gruys moved/seconded to approve the benefits package for FY25. Central Insure will take over the administration of our benefits and our LTD/Life insurance policies. The overall health insurance increase was 2.41%. All aye vote. Motion carried.

Stecker/Hamm moved/seconded to approve the Spirit Lake High School 2024 graduates list. All aye vote. Motion carried.

Gruys/Mouw moved/seconded to set a public hearing to dispose of staff computers and senior laptops for May 13th at 5:20 p.m. All aye vote. Motion carried.

Hamm/Mouw moved/seconded to approved the Technology Refresh for FY24-25. Next year we will update staff machines and Class of 2028 computers. All aye vote. Motion carried.

A discussion was held on the small wind turbine. Staff gave history of the equipment, steps taken to date to repair it, cost to repair it, and possible options for removal.
